National strategic reference framework

Consultations with EC on NSRF started on February 6, 2006

Operational programmes



Start of programming on October 18, 2005



First draft on November 16, 2005 (without allocations)



Second draft on January 31, 2006 (including allocations)



First drafs available from January 16



Several drafs during February - April



Start of public consultation on OPs on May 18

National Strategic Reference Framework – general info

- Based on the main principles and guidelines of:
 - Community Strategic Guidelines,
 - National development plan 2007-2013
 - Lisbon National Reform Programme
 - Joint Economic Strategy
- Three tematix axes:
 - Development and efficient utilization of resources
 - Strenthening competitiveness and progress towards a knowledge-based economy
 - Improvements in public services and infrastructure as a precondition for balanced national and territorial development



Main stakeholders

Approval of NSRF, allocations and OPs
Leading institution
Coordinating the programming in Latvia
Ensuring coherence with National Development Plan
Communicating with European Commission
Preparing the content of sections in NSRF, operational programmes and justification of allocations
Providing comments and input into draft documents
Reviewing the state of programming, no active involvement in the programming

Allocations

- Wish-list of sector ministries together with draft description of OPs
- First proposal of allocations for sectors approved by Government
- Report to Goverment on programming prepared by Ministry of Finance
- Political discussions within Government, but no agreement reached
- Second draft allocations approved by Government; to be submitted to EC

Involvement opportunities for social partners and NGOs

- Writen comments on NSRF and draft OPs
 - One month commenting period from November 16 up to December 9, 2005
 - "Passive" commenting period during February May 2, 2006
- Stakeholder meetings with Ministry of Finance
 - About comments on NSRF (January 10)
 - About comments on draft OPs (February 14-16)
- Bilateral meetings with sector ministries
- Bilateral meetings with Ministry of Finance and representatives from Prime minister office
 - About priorities and allocations



Availability of information

- Most of information is available from www.esfondi.lv
 - Draft NSRF
 - Draft OPs and several updates
 - Comments on NSRF and OPs by sector ministries, social partners and NGOs
 - Reports and presentations prepared by MoF to the Government about programming
 - Time line of programming and public consultations
 - First reaction and comments from EC on NSRF
- E-mail communication to social partners from Ministry of Finance about upcomming activities



Participation of environmental NGOs

- No official working groups for elaboration of NSRF and OPs
- 3-5 environmental NGOs and Advisory Council of Environmental NGOs permanently following the programming
 - Latvian Green Movement
 - WWF Latvia
 - Environmental Protection Club
 - Latvian Eco-tourism association
 - Latvian Small Energy Association
- Position papers focusing on energy efficiency, nature protection, sustainable transport and implementation of Water framework directive
- Press releases and articles in national newspapers
- Bilateral lobby meetings with Ministry of Environment



Main concerns and discussion points of environmental NGOs

- Allocated funds not sufficient for environment to meet requirements of EU directives (water and wastewater management, waste management)
- Lack of integration of environment as horizontal objective
- Lack of integration of environmental aspects in the transport sector
- No soft measures envisaged in the OPs "Infrastructure and services" environmental part



Participation of social NGOs

- Involvement of most active NGOs
- Position papers and comments to the draft documents
- Media work
- Several bilateral meetings with sector ministries and Ministry of Finance
- Main demands:
 - Increase financing for development of human resources
 - Increase the share of ESF against ERDF
 - "More money in humans and less in the asphalt"



Conclusions *Positive remarks*

The process

- Draft proposals and communication of ministries published in the website
- Institutions open to meetings with social partners and NGOs
- NGOs can play constructive role and have a position
- Issues broadly discussed in the media

The contents

- Financing from CF envisaged for energy efficiency under sustainable development priority
- Financing increased for development of human resources and environment
- Environmental and social NGOs have had some influence on the content of OPs



Conclusions *Negative remarks*

The process

- Changing the deadlines
- Poor coordination between sector ministries
- Some ministries were not active in defending their priorities

The contents

- Lack of integration of environmental aspects into other sectors
- The increase of financing for environment from Cohesion Fund was less than MoE and environmental NGOs asked for
- Political priorities appearing without justification for their need
